**At UCO, prerequisites for some of the courses above will include MATH 1513, 1593, CHEM 1103, 1112, BIO 2314/2203, STAT 2103, and PSY 1103. # PRE-OCCUPATIONAL THERAPY

Occupational therapy is therapy based on performing the meaningful activities of daily life (self-care skills, education, work, or social interaction), especially to enable or enhance participation in such activities despite impairments or limitations in physical or mental functioning. Occupational therapy is for individuals of all ages to improve skills that help them perform daily tasks at home and at school, at work and at play. Occupational therapy practitioners are skilled professionals. Their education includes the study of human growth and development, with specific emphasis on their “occupations” of living. Occupational therapy practitioners are unique in that they look at the whole picture when it comes to a person’s treatment—the individual’s abilities, the task to be performed, and the environment in which the task takes place. National average salaries for Occupational Therapists is around \$80,000.

**APPLICATION REQUIREMENTS:** Admission to the program requires completion of prerequisite course work and submission of all application materials. The Department Admissions Committee will review application materials. To be considered for admission to the Occupational Therapy Program, an application must:

1. Have successfully completed, or be in the process of completing, a minimum of 90 semester hours of prerequisite course work from an accredited college or university prior to matriculation to the program. **Effective for 2019 admission, a bachelor’s degree must be earned prior to enrollment in the program;**
2. Be in good standing with the college or university last or currently attending;
3. Have a minimum cumulative and science grade point average of 2.75 on a 4.0 scale for all college work and nature science courses attempted. **A recently admitted class had an average GPA of 3.7 overall and 3.51 in sciences.**
4. Have completed all department prerequisite courses with grades of C or better. **All attempts of a course are included in the calculation of GPAs;**
5. Document 40 hours of observation experience in an occupational therapy setting prior to application;
  - To get started, call a facility that employs Occupational Therapists and ask if they will allow you to job shadow or contact one of the professionals identified on the OUHSC College of Allied Health Shadowing Map: <http://www.alliedhealth.ouhsc.edu/ProspectiveStudents/ApplyingtoaProgram.aspx>. 6. Submit GRE scores. **A recently admitted class had average GRE scores of 300/4.0**
7. Students for who English is a second language must submit a minimum score of 600 (paper-based) or 100 (internet-based) within two years prior to application on the Test of English as a Foreign Language (TOEFL).

## APPLICATION PROCEDURE

1. Submit the following by **February 1<sup>st</sup>**, of the year in which admission is sought:
  - A completed University of Oklahoma Health Sciences Center application;
    - <http://alliedhealth.ouhsc.edu/ProspectiveStudents/ApplyingtoaProgram.aspx>
  - A completed OTCAS application;
    - <https://otcas.liasoncas.com/applicant-ux/#/login>
  - Official transcripts from all colleges or universities attended;
  - Documentation of observation experience (40 hours);
  - GRE scores; and
  - Non-refundable application fees.
2. A letter of acceptance, alternate status, or denial to the OT program will be mailed the latter part of April. If notification is not received by May 1<sup>st</sup>, contact the department.
3. The applicant must accept the position in writing within two weeks of notification and confirm their intention to enroll and attend with a non-refundable deposit. The deposit is applied toward tuition and fees during the first term or the position will be considered declined. Alternates will be selected according to numerical ranking. Alternates may be admitted up to the first class day for the summer term if all positions have not been filled.
